Answer: FDIC insured up to \$250,000.

 - Isolation of groups: social events around them?? Also, the comment of registering zoom and newly formed in person groups would make meetings less isolated
- **Group 3**-- Newsletter not necessary
- Group 5-- Bookstore: confusion over lack of information. What are the options?
 Need to know more about Book sales
 - WSO or Intergroup sites were preferred sources of events rather than a newsletter
 - Suggestion: Create a pool of speakers who would be willing to qualify at meetings listed on the intergroup website as a source
- **Group 6**-- Intergroup should make the call on effective costs and whether to keep the store, no newsletter, go to website, people make announcements about what's coming up soonest in the future
 - Website vs Literature in NYC: (?) How much is the physical bookstore used?

Meret- Intergroup will generate information about the cost of selling books. Charlie- The World Service Office does efficient inventory control and runs an online bookstore. Having Intergroup do the same is a duplication of effort.
